The role

The Department of Politics & International Relations (DPIR) is seeking a well-organised HR Officer to join the professional services team. DPIR is a busy teaching and research department and the successful candidate will report to the HR Manager and work alongside a second HR Officer, as support the DPIR Professional Services team and other Divisional and University HR teams to provide a professional and efficient HR service to all DPIR staff.

The role involves liaising with a wide range of people and includes coordinating staff recruitment, administration of HR data (using the University's PeopleXD system), administration of leave and absence, monitoring and supporting visa applications, drafting contracts (main payroll and casual), and being a general point of contact for all enquiries. The HR Officer will also be expected to get involved in all other aspects of the HR function,





including supporting in areas such as staff initiatives and continuous improvement, ad-hoc projects, briefings, and training sessions, and compiling and providing information for internal communication or reports.

The HR Officer will be expected to have relevant HR experience and be willing to further develop their knowledge and experience in an academic environment. They will have experience of providing a high-quality customer service, excellent attention to detail and an ability to work effectively both independently and collaboratively as part of a wider team.

Responsibilities

Support

- Develop good working relationships with managers and colleagues in the department and wider university
- Act as first point of contact for HR enquiries. Confidently advise line managers and staff members, using appropriate methods of communication tailored to the audience answering straightforward questions or researching employment law, interpreting procedures to answer more complex questions, or redirecting as appropriate
- Provide general administrative support for the HR team and support and educate managers on best practice, under the guidance of the HR Manager.
- Contribute to project work independently or collectively as required by the HR Manager
- Provide administrative support for PDRs, the Reward and Recognition exercise and family-friendly policies

Transactional

- Implement University HR policies and procedures, providing data by running ad hoc reports from appropriate HR databases (e.g. PeopleXD)
- Manage the administration of recruitment exercises for professional service and faculty staff which will include; working with managers to understand their staffing requirements, designing effective job advertisements and job descriptions ensuring that they comply with University guidance and best practice, making sure that adequate funding is available, submitting new posts for grading, placing advertisements, gathering information for visa applications where necessary, generating letters to applicants, and preparing short listing packs

- Prepare standard letters of appointment (staff and casual workers/teachers), and contracts ensuring that relevant right to work documentation, Occupational Health and ID checks are completed, and HMRC IR 35 rules are applied for consultants
- Planning and carrying out induction sessions for new staff ensuring that appropriate preparations are made for the arrival of new staff, including setting them up on the payroll system and sharing relevant information with their line managers, supervisors and mentors, as well as the Operations Team.
- Completion of monthly payroll changes adhering to the University's deadlines, ensuring that the correct funds are utilised, the correct funds are utilised, payroll costings are correct (liaising with the department Finance team as appropriate) and ensuring University payroll procedures are complied with

Compliance

- Monitor fixed term contract processes, sick leave absence records, annual leave records, end of probationary periods and annual appraisal dates and inform the HR manager/ Head of Administration and Finance of any action to be taken
- Accurately maintain all confidential personnel records using existing systems (e.g., PeopleXD) and creating appropriate local systems as needed, taking into account the GDPR and Information Security policies, including with regards to retention
- Ensure all visa applications and renewals are conducted in accordance with Home Office regulations, making sure all the relevant documentation is up to date and compliant. Liaison with the University Staff Immigration Team where appropriate
- Keep up to date with University systems and processes relating to HR, attending appropriate briefings and training
- Any other duties as deemed appropriate by the HR Manager or the Head of Administration & Finance that are commensurate with the role

Additional duties:

As a new starter, you will be expected to complete required training for the department and, if applicable, your role, these include:

- Information security and Data Protection
- Implicit Bias
- Bullying and Harassment training



- Equality and Diversity briefing
- Harassment in Higher Education

Selection criteria

Essential

- Hold or working towards CIPD Level 3 qualification
- Demonstrable HR administrative experience, including previous recruitment experience
- Knowledge of employment law and ability to understand and engage with the academic employment context
- Awareness and understanding of the principles of data protection and information security guidelines, and willingness to engage with new regulations as they arise
- Ability to clearly and accurately communicate HR processes and procedures and to communicate effectively with a diverse audience
- Excellent organisational skills with a demonstrable ability to prioritise workload, and deal effectively with a variety of tasks, producing accurate, detailed work within deadlines
- Experience of providing a high level of customer service
- Excellent accuracy and attention to detail
- Very good IT literacy: evidence of competence with MS Office, particularly Excel, Word and email and the willingness and ability to learn new IT applications
- Ability to work both independently and collaboratively as part of a wider team
- Willingness to undertake professional development and training
- Understanding of the University's obligations under the Equality Act 2010 and the Public Sector Equality Duty

- Experience of working in a higher education environment
- Experience of working with an electronic HR system (such as PeopleXD)
